## OTHER RELEVANT FEDERAL INFORMATION:

Drug-Related Convictions and Student Ineligibility – Title IV eligibility is suspended for a student convicted of violating any Federal or State drug possession or state law.

For a drug possession conviction, eligibility is suspended one (1) year for a first offense; two (2) years for a second offense and, indefinitely for a third offense. For a drug sale conviction, eligibility if suspended: two (2) year for the first offense and indefinitely for the second offense. A person's Title IV eligibility may be resumed before the end of the ineligibility period if (1) the student satisfactorily completes a drug rehabilitation program that complies with criteria established by the Secretary and such program includes two unannounced drug tests or (2) the conviction is reversed, set aside, or otherwise rendered nugatory.
